
Four years have passed since this Company and the World Traders received their Grants of Livery in these same surroundings. When the Master, Dr Kevin Bond, spoke it was reassuring to be reminded that membership of the Company has grown by 50% in that relatively short time. And in his response the Lord Mayor, Alderman Robert Finch, made flattering reference to both the significance and the progress of this, one of the City's youngest Livery Companies.

The vital role played by Sir Hugh Myddelton in the history of the City's water supply is marked by the Company in several ways. The wolf's head from his Coat of Arms appears both on our own Coat of Arms and also on the Beadle's staff. Sir Hugh was a wealthy Goldsmith

in the City who was able not only to initiate the New River project successfully after many years of inconclusive discussion and also, when money ran short during construction, to enlist the assistance (on terms) of King James I. One of his brothers was Sir Thomas Myddelton, Lord Mayor of London in the year that the New River was completed, who attended the ceremony held at the terminal reservoir in Islington which marked the availability of the first really substantial quantity of fresh water for distribution in the City.

WaterConservators raise a toast to international water quality

The Water Conservators played host to an international delegation of over 170 chemists, biologists and microbiologists at a drinks reception in Cardiff during October.

Scientists representing 18 different countries, had gathered in the Welsh capital for the annual conference of the water quality and water analysis technical committees of the International Standards Organisation (ISO) and its European counterpart, (CEN).

Speaking at the reception, the Master, Dr Kevin Bond, delivered a brief history of both the Livery movement and the Water Conservators, much to the interest of the audience - in particular those from Japan and the USA.

Later, the Master was able to renew acquaintances with old colleagues from his time as Chief Executive of the former National Rivers Authority as an enjoyable evening was had by all, with wine and water flowing.

"The ISO and CEN technical committees for water quality run in parallel with each other to avoid contradiction or duplication," explains Sue Owen, Court Assistant and leader of the UK delegation of chemistry experts at the conference.

"The ISO group was first established in 1975 by some 20 countries joining together in order to develop and maintain a series of ISO standards for water quality control. Then in 1990, a similar body was required by CEN, to establish methods for existing and future European Union (EU) guidelines on water quality and it made sense that the committees run together.

It is vital to have appropriate methods of analysis for potable, marine, river, waste and ground waters in order to comply with regulation. Committee discussions are fed back to national committees, such as our own BSI (British Standards Institute) and used as references for water companies and environmental agencies.

One of the main items on the agenda at this meeting was the suitability of detection limits and methods for the new list of priority pollutants which require measurement under the EU Water Framework Directive

On a lighter note, participation in the conference also provides a great chance to meet up with old friends and colleagues and is always a

hugely enjoyable social occasion. Delegates at the Cardiff event were intrigued by the traditions and history of Wales and its mother tongue and are already looking forward to the next conference in 2005 which will be held in Japan."



SPALDING GENTLEMEN'S SOCIETY

The emblem on it, which is also on the cover of the Society's annual reports, is the Water Bouget, taken from the armortal bearings of Maurice Johnson. the Society founder. The Water Bouget is a frequently used beralds device derived from leather water bottles carried on a yoke. It has taken various forms from simplified to ornate, and the more decorative form, illustrated here, is used on the annual report. It is a heraldic pun on the initials of the founder, M.J. The armorial bearings were originally granted to Maurice Johnson's great great grandfather, Martyn Johnson, ford of the manors of Aunby and Sutterton.

Derek Wilfred Berry

Derek Berry, a Freeman of the Company and an enthusiastic Member since 1993 died on Friday 25h July 2003, aged 74 after a long battle with motor neuron disease. His career in water engineering with Howard Humphreys and Partners Consulting Engineers, embraced water resource development, water treatment and distribution as well as irrigation. He was a Fellow of the Institution of Civil Engineers and a Member of the American Society of Civil Engineers.

Joining Howard Humphreys from Portsmouth Polytechnic as a pupil in 1952 Derek progressed to Associate Partner in 1974 and a Partner/Director from 1979 to his retirement from full time employment with the firm in 1986. a daughter from a previous marriage.

His experience with dams and water supply was gained from projects in the Caribbean, site work in Trinidad from 1956 to 1959. Africa and the Middle East. He was awarded the Institution of Civil Engineers 1971 George Stephenson Medal for his joint paper on 'Extensions to the Chania-Sasuma Water Supply Scheme for Nairobi'. From 1973 he was a Panel 1 Engineer (Reservoirs Safety Provisions Act 1930) and from 1985 he was a Member of Panel AR (Reservoir Act 1975).

With Howard Humphreys, Derek was responsible for water supply to major sugar projects in West Africa at Ferkessedougo and Save including dams and irrigation as well as water supply schemes for the Seychelles and he became proficient in French for the African projects. He was also responsible for extensions to Nairobi's water supply.

Working as an independent Consultant from 1986 to 2000 Derek continued his dam assessment work for a number of U.K. Consultants on international projects and also for dams and reservoirs in China and Hong Kong through a local office.

At home at Whitehill, Hampshire, Derek's interests included bridge, bowls, fine wines and gardening. He is survived by his widow, Angela and
