# **The Worshipful Company of Water Conservators**

## **Joining options for 2022/23**

### **Freedom & Livery**

The Application Form can be downloaded from the Company Website which, upon completion should be submitted by post to the Deputy Master, Peter Hall with the relevant remittance. A Liveryman having first become a Freeman of the Company, and then of the City of London, is entitled to attend any Company Event and any City Event open to Liverymen of the City of London, including the Elections of Sheriffs and the Lord Mayor.

The costs would be an initial payment of £250 and thereafter an Annual Fee (Quarterage), payable in July of each year; the Quarterage payment currently stands at £325 per annum. If you join part way through a Company year (July to June), your first year's Quarterage will be pro-rated to reflect the number of complete months remaining in that Company year. The initial payment of £250 should be made by cheque, payable to "The Company of Water Conservators". All subsequent payments will be by Direct Debit (the relevant mandate can be downloaded from the Company's Website).

### **Freedom**

The Application Form can be downloaded from the Company Website which, upon completion should be submitted by post to Deputy Master, Peter Hall with the relevant remittance. A Freeman is entitled to attend all Company Events including either 2 of the Company's 4 core lunches or 1 of the Company's 4 core lunches and the Annual Banquet. In addition, a Freeman of the Company is entitled to attend any City Events which are not exclusively for Liverymen. The cost would be an initial payment of £100 and thereafter an Annual Fee (Quarterage), payable in July of each year; that payment currently stands at £150 per annum. If you join part way through a Company year (July to June), your first year's Quarterage will be pro-rated to reflect the number of complete months remaining in that Company year. The initial payment of £100 should be made by cheque, payable to "The Company of Water Conservators". All subsequent payments will be by Direct Debit (the relevant mandate can be downloaded from the Company's Website). At the point when you might progress to become a Liveryman of the Company there will be a fee to pay of £150, this being the difference between the joining fee of a Liveryman and the joining fee of a Freeman.

## **Associate Membership**

The Application form can be downloaded from the Company Website which, upon completion should be submitted to Prof. Martin Bigg with the relevant remittance (as applicable). An Associate Member is entitled to attend Company Webinars and participate in the Company's Associates programme of events. The cost would be an initial payment of £50 and thereafter an Annual Fee (Quarterage), payable in July of each year, that payment currently standing at £50 per annum. The initial payment of £50 should be made by bank transfer or cheque, payable to "The Company of Water Conservators". If paying by bank transfer, the bank account details will be provided via email upon receiving the completed application form. All subsequent payments will be by Direct Debit (the relevant mandate can be downloaded from the Company's Website). It is envisaged that an Associate Member after a four-year period will seek to move forward to become a Freeman or even a Liveryman of the Company.
