Dr Marion J Carter B.Sc., Ph.D., C.Geol., F.G.S., C.Chem., M.R.S.C., Eur Chem., F.Inst.W.M., F.I.Q.

Marion Carter is a hydrogeologist who more than 20 years ago founded MJCA, a specialist consultancy employing 50 people who provide to industry technical advice on scientific issues.

Marion graduated with a first class honours degree in Chemistry and Geology and stayed on at the University of Aston in Birmingham to become the first person to undertake a PhD in waste management following three years research into the hydrogeochemistry of liquid waste disposal. Apart from a two year period in the 1970s spent as a Water Quality Officer with Severn Trent Water Authority she has spent her whole career as a consultant.

Marion has always taken an active interest in professional issues and has sat on the Councils of the Geological Society and the Institution of Geologists. She is a Chartered Geologist and a Chartered Chemist, a Fellow of the Geological Society, a Member of the Royal Society of Chemistry, a Fellow of the Chartered Institution of Waste Management and a Fellow of the Institute of Quarrying. She was a member of the Board of the **Environmental Services Association** for many years and at various times has been the Chairman of the Training Committee, the Planning Committee, the Public Affairs Committee and the Human Resources Committee.

She has served as a member of the NERC Council and of the Board of the British Geological Survey. For the past four years she has been a member of the DTI Small Business Council. Through her interests in professional and trade matters Marion has been involved in Europe and in the UK with the development of policy in waste and contaminated land.

Her interests include reading, walking and horse riding. She has a small herd of pedigree sucker cows.



Writing this report at the end of my term of office as Master of the Company I am amazed at the speed with which the year has passed. I do not think that this is simply a matter of age, but rather a function of how many different things happen whilst one is Master.

I said, at the beginning of my term, that I would want to focus on the internal processes of the Company and try to ensure that they were better when I left office than when I arrived. Only time will tell if this has happened. What we have done is to put into place a new audit arrangement and, as a result, a set of procedures to control the financial processes. This is not, I hasten to add, because of 'problems' with our finances but because I believe that we must be seen to embrace the best practices which we see business adopting. Corporate governance has a role for us too!!

None of what I have done during this past year would have been possible without the help and involvement of others. First, there is the Clerk Ralph Riley. Ralph is always either present or at the end of a phone to answer questions and explain the precedents. The City is not without its challenges and the newest company is assessed alongside the Great Twelve. The Wardens are of enormous support and will always lend a hand even though they are swimming hard to stay afloat in their own busy schedules. In particular I have to thank this year's Thames Warden Marion Carter for both her support and friendship. Sue Owen has been a Tower of Strength as chairman of the Finance and General Purposes Committee. It is through this committee that all business is transacted at some stage in its progress; thank you Sue.

Have you ever stopped to think of all the many members of our company who are actively involved in making it work. I have mentioned our Clerk, the Wardens and Sue. There is also the Court, the Past Masters and the Committee members; not only the FM & G.P, but also the Charities and Grants, a new Audit Committee and the Strategy Working Group.

This year has also seen the completion of the restructuring of our Charities. We are all aware of the central role charity plays in the life of the livery. Our Hon Solicitor and Fleet Warden, David Jones has steered us through the merging of our two old charities into one Water Conservation Trust. Many thanks to the trustees of both of the old charities for all they have done to facilitate this and to the trustees of the new charity, and in particular Jeff Rasbash for taking the chair of this new Committee of Trustees. We all must get behind this Charity and make our support tangible through charitable giving.

During the year it has also been a pleasure to help greet the City's newest Livery Company; The Worshipful Company of Hackney Carriage Drivers as Number 104. Yes, since we took livery, there are now two behind us number 103 being the Firefighters and there are others preparing to take livery such as the Management Consultants and the Security Professionals. Livery remains a vital and relevant movement and very much at the heart of how the City of London functions.

I have also reported in this edition of the newsletter on the functions I have attended this year on behalf of the Company, what I cannot give a sense of is how vibrant and current the livery is in the City. This is one of the reasons why the City is such a power house, not just in the UK, but also internationally.

I must take this opportunity to thank the speakers at our dinners and lunches during this past year; Bob Mark, Sir John Harman, Hugh Berridge and Alderman Robert Finch the Lord Mayor. I reserve my final comments to pay tribute to the Past Masters of this Company. They, in the collective but, particularly in the individual, have been a huge source of strength and advice to me. It was our Past Master and Clerk Emeritus, Hugh Berridge who brought me into the Company and has continued to be an enormous support to me. It is the Past Masters who have always been there to proffer advice and support during my year. Gentlemen, a very big thank you.

To all my fellow Freemen and Liverymen of The Worshipful Company of Water Conservators, a humble thank you for the honour you have given me to serve as your Master for the year.

Report on Activities

The year just finishing this July has been hugely interesting to me as your Master. I have expressed my appreciation to the many who have helped and supported me in the company. There have been countless others in the wider livery movement and the City with whom I have had contact during the year.

The Master of the Company of course is invited to a range of functions, ranging from Dinner and Lunch to the City formalities. During the past year I have been privileged to attend the installation of the new Master of the Scientific Instrument Makers and to have lunched or dined with the Weavers, Master Mariners, Launderers, Information Technologists, Butchers and Farmers to name a few. I thougherly enjoyed attending the Annual Dinner of CIWEM and meeting many old friends and work colleques at a time of such change for those of us involved in the water and environmental movement.

The joint lecture we held with the

Insurers on the flood risk to the City by the River Thames which was given by the Chairman of the Environment Agency; Sir John Harman was very well received. We were very fortunate to have the Masters of a number of other Livery Companies present for the lecture as well as Liverymen from the Insurers and our own Company.

Our 'In House Party', the Annual Banquet was huge fun and Sue and I enjoyed this event probably above all others as it is a sharing of fellowship within the family.

For pomp and a sense of having made it! the Myddelton Lunch, held at Mansion House in the presence of, and with the support of the Lord Mayor and Lady Mayoress, cannot be beaten. The United Guilds Service, one of the services in St Paul's held during the year, was preceded the night before by Dinner for the Upper Bailiff, Masters and Prime Wardens of all Livery Companies in the Mansion House hosted by the Lord Mayor. For all the splendour of Mansion House, there is, I think, a very special sense of occasion to be in St Paul's when it is full of Liverymen and the beautiful sound of choral music.

Our joint Carol Service with the Fuellers was a wonderful lead-in to the celebration of Christmas and just one example of the way in which companies are sharing the whole livery experience in an increasing way.

Our cutter, The Water Forget Me Not, participated in the Port of London Challenge, The Admirals Cup and the great progression of our 'Stella' from Hampton Court to the Tower of London with me somewhat precariously seated in the rear trying to give encouragement to the oarsmen pulling my dead weight along the Thames. Despite

the obvious handicap of an overweight Master, our crew completed the year once again with a clean sweep of victories.

Finally, there were, of course, our other Company functions; the Installation Lunch and the Michaelmas Lunch. These wonderful occasions of the Company coming together to share friendship and food. My report on activities for the year must conclude by thanking all who either offered hospitality or took a share in our hospitality every thanks for their friendship.

Charity Update

Merger and Management

Members of the Company were recently advised that the Company's two Charities were to be merged into one. That process is now complete. All the beneficiaries of the Charitable Trust Fund (CTF) have been taken over by the Water Conservation Trust (WCT), and the proceeds accumulated investments have been transferred to the (WCT). The WCT is supervised by six Trustees. Although they are members of the Company, they act independently of it and are personally responsible for the well being of the Charity under the law.

Pupils' Prizes

The Company's initial major educational initiative, the Pupil's Prizes scheme, is increasingly being taken up by members. The scheme encourages children at any local school in their study of water and conservation. Pictures of some of the prize winners have appeared

Water Conservation Bursaries

CIWEM Young Members Study Tour. - Financial support for members of the Military Works Force to attend the Institution's annual study tour.

Tony Drake Scholarship. - A travelling scholarship to contribute to the study of a water conservation related topic, in another country.

Maidstone Sea Cadets. - General support of the cadets to participate in seafaring activities.

City of London Freeman's School. - An annual grant to support conservation activities in the form of a book presented at the Annual Prize Giving and Open Day.

Dissertation Prize. - Annual prize given for the best dissertation, presented for the UEL MSc in Pipeline Technology and Network Management.



Previous Projects

Our Charities have been active since we were a Guild and have supported numerous projects, some of which arte listed below.

Water Champions Venture. - Seed-corn funding for PENON Water Champions programme which is administered by the Devon & Cornwall wild life trusts. It helped both trusts to carry out their work on nature reserves, rivers and wetlands.

SEMAT - A DTI Programme providing support for overseas personnel for the Secondment to European Measurement and Testing programme.

Shoals of Capricorn. - A research project entailing a hydrographical study of the area.

National Grid of Learning. - The establishment of a national curriculum website dealing with water conservation issues.

LOGVEC - General livery support for establishing links with schools local to the City.

The University of East London. - Seed-corn funding to support the establishment of new Professorial Chair to serve the water industry.

Thames Cutter - Assistance with the purchase of a cutter to train young oarsmen, which is also used on company ceremonial occasions.



Liveable City Awards - A grant to the conservation section of the Corporation of London Sustainable City Forum.

Future Projects

The trustees are always pleased to know of any relevant projects, or ideas for sponsorship, and Liverymen and Freemen are encouraged to share them with the Clerk who will pass them on to the trustees! Some of those under consideration are as follows.

Conference sponsorship. - Funding for full-time students to attend relevant industry conferences and seminars at home and overseas.

Sponsorship of young persons with a disability. - Awards to facilitate enjoyment of the water environment.

Resource research - Identification of the industry's future educational and professional needs.

The Deputy Master, Dr Kevin Bond said in his recent letter to members

"Charitable giving sits firmly at the heart of all City of London livery companies and I'm very pleased to say that due to the continued generosity of liverymen and freemen, our Company is no exception to this." Most Water Conservators entered covenants or made gift aid donations to our charities when they first joined the Company. Their generous gifts allowed the charities to establish and develop the capital investments, which are expended each year on the Company's existing charitable projects. However, the majority (although not all) of the covenants are now time expired. It is hoped that members will be kind enough support our charity once more. Once members have had a little time to digest the contents of the Master's letter, senior members of the Company will be making personal contact with all liverymen and freemen to encourage them to enter into some form of giving, to support the work of the Trust.

A Potted History

And in the beginning there were two institutions, I.P.H.E. and I.W.P.C. and these two institutions were associates of an American organisation W.P.C.F.

And a man came from across the water and he said unto these two institutions, "From now on, thy leading members shall become Sludge Shovellers", and the institutions obeyed and begat the Select Society of Sanitary Sludge Shovellers.

And after some years, the Shovellers thought they might do something useful, and a man called Berridge suggested that they might do something in the City of London.

And a deputation went to see people in the City of London, who said, "A Company of Sludge Shovellers? Not on your Nelly!" And it was found that one Shoveller, a man called McDowell, was already a liveryman of the City of London and was well versed in the City customs and practices.

Therefore it came to pass that at a meeting held at the Institution of Civil Engineers, chaired by the said McDowell, a Guild of Waterbearers came into being. But the Waterbearers had made a mistake, saying that they were the only people in the City from the water industry.

And this was wrong, as the Worshipful Company of Plumbers told them in no uncertain terms as some of their members were on the pure water side.

The advice was to the new Guild that they could not become a Company until they had sorted matters with the Plumbers, but lunches and representations felt on stony ground and to try to please the plumbers, the Guild changed its name to the Guild of Water Conservators.

The man tasked to take the Guild to livery status was the same McDowell and, being a forthright engineer, he said, "Sod this for a game" and persuaded the Court to apply for Company status.

The City Fathers, in their wisdom, did direct that the two parties should meet and the then Master of the Guild, one Shirley, was a naval man used to pouring oil upon troubled waters and in the meeting, he used the utmost tact and diplomacy and the problem was resolved.

At a meeting of the City Fathers, the appointment of the Water Conservators as a Company without Livery was approved and the three observers, the Master Harris, the same McDowell and one Ralph Riley, did shout "Hurrah" and drank a bottle of Champagne before disposing of the bottle in an environmentally friendly manner.

And the new Company. sponsored by a previous Lord Mayor and ably led by the Clerk, the same Berridge, with excellent Masters, did comply with all the customs and traditions of the City of London.

And the City Fathers said, "Behold, this is a good and worthy lot. They shall become liverymen."

And so it came to pass, with the new millennium, that the Company, at an imposing ceremony in the Mansion House, did become a Company with Livery.

And a little while later, at a ceremony in the Guildhall, many members of the Company were clothed as liverymen and there was great rejoicing.

And, thus, the Company became Worshipful. May it flourish, root and branch, forever.

Consequently the Company has sort out a very suitable candidate.

David Lawrence was a competent oarsman but excelled at racing kayaks at World Championships and at other major events on the international circuit - that is until age caught up with him.

He now runs the Royal Canoe Club at Teddington which is one of the national training centres for the sport but also includes within its family both Walbrook Rowing Club and the Skiff Club.

Until recently David was the Head of Navigation for the Environments Agency but in a previous job with the London Region of the Sports Council he was part of the group that established the Great River Race and the building programme for the Thames Cutters. An initiative that has blossomed into the programme of events run by the Thames Traditional Rowing Association - the events in which the Worshipful Company of Water Conservators rule the roost.

The Great River Race

This year the Company entered into a partnership with the City of London, Naval Reserve Unit at HMS President.

The event is for all kinds of traditionally rowed craft, intended to recreate the journeys on the river that have taken place since Henry VIII licensed the first Watermen during the 1500's. Each craft therefore has to carry a passenger and fly a suitable flag to indicate its affiliations. Craft take part that are as different as - 'Captain Blyth's jolly boat' from the Bounty to the sleek 'Cornish Pilot Gigs' and each is handicapped over the course. None the less a record entry of 280

This year the event took place on Saturday the 11th of September from Ham House, in Richmond, to the Mast of the Cutty Sark, in Greenwich - a distance of 28 miles.

The event was rowed in a strong head wind that made conditions through the City difficult as standing waves build up down stream of the major bridges. Downstream of Tower Bridge the head wind was more difficult to row against, particularly for crews already on their last legs.

boats carrying crews of at least 6 rowers, as young as 14 and as old as 70, take part. Our crew of Naval Matelots completed the course within 3 hours, which at the very least provided very good training for the London Services Challenge - the Fishmongers Cup that is to be rowed on the 25th September between the Fire Brigade, Police, Port of London Authority and the Cities Army, Naval and Air Force Units.

On this occasion there was a technical hitch...the Company had no Thames Warden. 
