

#### **OBITUARY | Charles William Michael McDowell** Founder Master 1988 – 1990



Mike McDowell was born in 1928 and died after a long illness on 11th July 2014.

As a boy, he lived in Huntingdon where he attended the local grammar school and then went to University College London. An only child, he sang in the Church choir and enjoyed village life. His main interest was cross-country running which he started as a schoolboy and enjoyed immensely. He joined

Ranelagh Harriers club in Richmond while at university and continued running into his late 70's. After that he officiated in many local running events in Gloucestershire.

After graduating with a degree in Civil Engineering, Mike went to work in Africa, designing and making roads through the jungle with a team of local men.

When he returned to England he met his future wife at a University dance, he married Diana, a teacher, and was a father of three daughters and a son. He became a grandfather of nine grandchildren, and one great grandson - all of whom brought him great pleasure and interest in their development.

He was very proud of his children, one a nurse, one an occupational therapist, one a doctor and his son a civil engineer. When the youngest one was still a baby, together with his wife he set up his own Civil Engineering business in his dining room at home. He worked hard and hoped the baby wouldn't cry when his wife answered the phone. The business thrived, quickly moved into a small local house and finished up in an office, purposely designed by his partner and built at Ashtead in Surrey. Through hard work, both in England and abroad,

the partnership grew quickly and finally ended up with over 100 employees. He was responsible for many road improvements, waste water systems and sewage works. Many family holidays involved a sightseeing tour of a sewage plant or a drainage scheme! He was an excellent mathematician, quicker than a calculator he said, which helped make him the successful businessman.

Mike became the Founder Master of the Guild of Water Conservators, a Guild of the City of London. He enjoyed attending Livery Banquets and taking part in the Lord Mayor's Show, which he attended come rain or shine. The Guild became a Livery Company in 2000. He also became a world respected Arbitrator in Waste Water Engineering.

He was well respected for his work, and travelled all over the world both for work and then competing in the Veterans world running events, including Japan, New Zealand and many other countries. He enjoyed the fellowship of all the runners.

Mike retired at 60 leaving a large well established and respected partnership. He was pleased to leave Surrey and come to Gloucestershire, away from the noise and bustle of the city. He will be remembered for his love of his family, home, running club and enjoying the local Probus Club, his Bridge Club and village life, taking his dog Gary for a walk and having his children and grandchildren come to stay. He and Diana made a great team throughout their 58 years of marriage. He was witty and cheeky and enjoyed a joke with everyone he met.

He survived three different kinds of cancer and realised how lucky he was. He will be missed by many people.



## The Water Conservation Trust

Increasing awareness and skills in the field of water and environment is a key objective for the Trust and, during the year, trustees have reviewed the impact of the schools and universities education programmes and have made some changes.



For many years support the education of young people was implemented through the Pupils' Prizes Scheme, which is a school-based project providing prizes for projects undertaken by school children and supervised by Water Conservators. Take-up has been modest. In the meantime, the Trust has responded to a number of direct requests from schools for financial and technical assistance to improve science and environmental education. This experience has led to the development of Schools Projects, where the Trust and Company Members play an active role in delivering infrastructure and a sustained interest in the outcome.

A significant impact has also been made through technical and financial support to schools for special projects such as the management of ponds and an aquarium. These facilities allow the children to study water ecology, consider water quality and the need to balance the ecology of water life. The Pupils' Prizes Scheme will continue both as part of the Schools Projects and independently, but it is being complemented with more specific assistance requested by schools. This approach has been successfully trialled at Ruislip High School and at Ysgol y Gogarth, in Llandudno, and has been extended to schools in the Thames area.

This approach has also led to partnerships with commercial organisations, the Royal Air Force and local charities. Recent projects in London have led to close links with Thames Water.

Water Conservation Trust bursaries are offered to post-graduate students for Master's programmes related to water, environment and waste issues at UK universities. They are need-related which allows excellent students the opportunity to continue their studies. The programme is funded by the Trust, augmented by special grants from WAMITAB and the Environmental Services Association Education Trust. Since the Bursary Programme started in 2007, 57 awards have been made to 15 universities. In 2013-14 grants totalled £72,000. Apart from the direct benefit to the students, good working relations have been established with the academic departments, which have enabled trustees to offer four universities: Wadham Oxford, Brunel. Newcastle and Sidney Sussex Cambridge a new three-vear arrangements. These long-term relationships have for example, enabled Brunel to research issues relating to the Lost Effra project in London and Wadham to develop automated controls

for handpumps in Kenya. Funds are available for bursaries at other universities on a competitive basis.

The Trust continues to support Maidstone Sea Cadets and has offered financial assistance to enable them to build their own slipway. Trustees have worked with the Company in a range of charitable activities, including fulfilling a commitment to complete the publication of Reflections which had been masterminded by the late Nick Reeves. The book was published and surpluses have been given to the Stroke Association. The Trust contributes to the Lord Mayor's Charities.

The Trust relies on regular giving from members of the Company which gives it the opportunity to plan for the medium term. Trustees are concerned that this source has declined in recent years and have, in addition, raised funds through sponsored walks. The 2013 New River Sponsored Walk raised £2,500 for the Trust's schools programme and for WaterAid. This is to be repeated in 2014.

The Company itself makes charitable donations throughout the year following retiring collections at its Lunches. In the last year, donations have been made to the Hackney Carriage Drivers Magical Taxi Tour to Disneyland, Paris, WaterAid and the Black Environmental Network.

Mike was educated at Alleyn's School, Dulwich. He followed a career in Government Departments and a Research Council.

On leaving school he started his career in the Ministry of Works where he gained a grounding in job costing, wages, contracts and general administration of works services on the Civil estate. Subsequently he was involved with financial control of major construction projects for the Navy and then spent 3 years in Gibraltar dealing with the administration of works services for the Army, Navy and Air Force.

In 1976 he moved to the Social Science Research Council as Deputy Finance Officer. As well as budget control and accounting, he was responsible for the introduction of computerised accounting and administrative systems throughout the Council.

#### **OBITUARY** Hugh Bentall Berridge, MBE Master 1990 - 1991



Hugh was born on the 9th August 1932 and died after a short illness on 25th January 2014.

He was educated in Southend-on-Sea, Essex.

Although Hugh's education deemed him a scientist he was in actual fact a consulting engineer and as such specialised in industrial wastes and laboratory management.

Hugh over the years worked for many notable consultancy's until in later life he established his own consultancy in London and then went on to work for the Government specialising in measurements.

As he would say "It was measurement and not money that underpinned trade" and as such Hugh until his death worked unstintingly for DEFRA and the DTI in overseas territories.

The Water Conservators Company came about under Hugh's proposition with other members of the 5S's and in 1988 the Guild was formed with Hugh becoming the 2nd Master in 1990. In 1993 when the Guild became a Company Hugh took on the position as Clerk and after Livery Status was achieved in the year 2000 he became Clerk Emeritus.

Hugh being interested in Medieval History, Cricket and Polo is survived by his second wife Sue.
